**ORDER FOR CHANGE THE NAME OF INSTITUTION**

WHEREAS, the recognition was granted to the institution namely **S.M. Degree College**, Pali Dungra, Post Office – Sonkh, Mathura, Uttar Pradesh for B.Ed. course of one year duration with an annual intake of 200 students vide order No.NRC/NCTE/F73/UP-2368/2007/36303-36309 dated **18.06.2008** followed by revised recognition order for B.Ed. course of two-year duration with an annual intake of 200 students vide order No.NRC/NCTE/UP-2368/2015/11910 dated **06.06.2015**.

2. **AND WHEREAS**, as per records, the sponsoring society of the above institution is Shri Mohan Singh Shiksha Sansthan, Pali Dungra, Uttar Pradesh.

3. **AND WHEREAS**, the said sponsoring society i.e. Shri Mohan Singh Shiksha Sansthan has established a Private University namely **K.M. University**, Pali Dungra, Post Office – Sonkh, Mathura, Uttar Pradesh vide Gazette Notification dated 28/06/2023 under the Uttar Pradesh Private University (Four Amendment) Ordinance 2023 (UP Ordinance No. 9 of 2023).

4. **AND WHEREAS**, the Society has requested NRC to change the name of institution located in the campus of **K.M. University** and to change the affiliating University.

5. **AND WHEREAS**, the matter was placed before NRC in its 431<sup>st</sup> Meeting held on 09<sup>th</sup> to 11<sup>th</sup> December, 2024, the Committee considered the representation of the institution dated 17/01/2024 and decided to permit the change the name of the institution from **S.M. Degree College**, Pali Dungra, Mathura, Uttar Pradesh to **Faculty of Education, K.M. University**, Pali Dungra, Mathura, Uttar Pradesh for B.Ed. course. The Committee also permitted to change the affiliating body from **Dr. B.R. Ambedkar University**, Agra, Uttar Pradesh to **K.M. University**, Pali Dungra, Post Office – Sonkh, Mathura, Uttar Pradesh for conducting B.Ed. Course with annual intake of 200 students i.e. four basic units of 50 students each.

6. **NOW THEREFORE**, in terms of above decision of NRC the institution namely **S.M. Degree College**, Pali Dungra, Mathura, Uttar Pradesh is hereby permitted to change its name as **Faculty of Education, K.M. University**, Pali Dungra, Mathura, Uttar Pradesh for B.Ed. course and to change its affiliating body from **Dr. B.R. Ambedkar University**, Agra, Uttar Pradesh to **K.M. University**, Pali Dungra, Post Office – Sonkh, Mathura, Uttar Pradesh for B.Ed. Course with annual intake of 200 students i.e. four basic units of 50 students each.
