ORDER CHANGE THE NAME OF INSTITUTION

WHEREAS the recognition was granted to the institution namely **S.M T.T. College**, Pali Dungra, Post Office – Sonkh, Mathura, Uttar Pradesh for conducting D.El.Ed. course of two-year duration with an annual intake 50 students vide order No. **NRCAPP-797/200thMeeting/2012/24863-871** dated **03.07.2012**.

2. **AND WHEREAS**, the sponsoring society of the above institution is Shri Mohan Singh Shiksha Sansthan, Pali Dungra, Uttar Pradesh.

3. **AND WHEREAS**, the said sponsoring society i.e. Shri Mohan Singh Shiksha Sansthan has established a Private University namely K.M. University, Pali Dungra, Post Office – Sonkh, Mathura, Uttar Pradesh vide Gazette Notification dated 28/06/2023 under the Uttar Pradesh Private University (Four Amendment) Ordinance 2023 (UP Ordinance No. 9 of 2023).

4. **AND WHEREAS**, the Society has requested NRC to change the name of institution located in the campus of K.M. University and to change the affiliating body.

5. **AND WHEREAS**, the matter was placed before NRC in its 431st Meeting held on 09th to 11th December, 2024, the Committee considered the representation of the institution dated 17/01/2024 and the Committee decided as under:-

The original file of the institution along with other related documents, NCTE Act, 1993, Rules, Regulations, SOP, guidelines issued from time to time were placed before the Northern Regional Committee and the Committee observed the following: -

- *The recognition was granted to the institution namely S.M T.T. College, Pali Dungra, Post Office – Sonkh, Mathura, Uttar Pradesh for D.El.Ed. course of two-year duration with an annual intake 50 students vide order dated 03/07/2012.*
- *As per records, the sponsoring society of the above institutions is Shri Mohan Singh Shiksha Sansthan, Pali Dungra, Uttar Pradesh.*
- *The said sponsoring society i.e. Shri Mohan Singh Shiksha Sansthan has established a Private University viz K.M. University, Pali Dungra, Post Office – Sonkh, Mathura, Uttar Pradesh vide Gazette Notification dated 28/06/2023 under the Uttar Pradesh Private University (Four Amendment) Ordinance 2023 (UP Ordinance No. 9 of 2023).*

- The Society has requested NRC to change the name of institutions located in the campus of K.M. University and to change the affiliating University.

In view of the above, the Committee permitted as under:

- The name of the institution be changed from namely S.M T.T. College, Pali Dungra, Post Office – Sonkh, Mathura, to Faculty of Education, K.M. University, Pali Dungra, Post Office – Sonkh, Mathura, Uttar Pradesh for D.El.Ed. course.
- The name of affiliating body be changed from SCERT, Lucknow, Uttar Pradesh to K.M. University, Pali Dungra, Post Office – Sonkh, Mathura, Uttar Pradesh.

Order be issued accordingly.

6. **NOW THEREFORE**, in terms of above decision of NRC change the name of the institution namely **S.M T.T. College, Pali Dungra, Post Office – Sonkh, Mathura** is hereby to change its name as **Faculty of Education, K.M. University, Pali Dungra, Post Office – Sonkh, Mathura, Uttar Pradesh for D.El.Ed. course** and to Change the affiliating body from **SCERT, Lucknow, Uttar Pradesh to K.M. University, Pali Dungra, Post Office – Sonkh, Mathura, Uttar Pradesh** for conducting **D.El.Ed. Course** of two year duration with an annual intake of 50 students.
