

**MEMORANDUM OF UNDERSTANDING
BETWEEN K M UNIVERSITY

THIS AGREEMENT (the "Agreement") is made at Mathura on this 01 Jan, 2024 and shall be effective from 01 Jan, 2024 between,

KM University, Pali Dungra, Sonkh Road, Mathura, Uttarpradesh

&

A TO Z Education Society, Fatehabad (Haryana)

WHEREAS

- The KM University is a UGC approved university established under Uttar Pradesh State Act No 09 of 2023
- A TO Z EDUCATION SOCIETY is a professional educational service, support and development organization which focuses on higher education sector.
- That both parties are desirous of executing an agreement in mutual interest for the benefits of students of the KM University in respect of the subject matter hereinafter contained.
- A TO Z EDUCATION SOCIETY will be the admission partner, providing Part -time and Full-time students for Regular Ph.D. and other programs.
- A TO Z EDUCATION SOCIETY counsel as direct students to join universities for Ph.D. program's and the total fee will be deposited in university account only and KM university will transfer admission fees to A TO Z EDUCATION SOCIETY as incentive INR 50000.00 (Rs 20, 000/- in first year Fee + 20000/- Second Year Fee + Rs 10000/- Third Year Fee) /Admission as per the agreement.
- Total Fee breakup include Registration Fee & Thesis Submission as below:
 - The Total PhD fee for **art subjects** will be Rs. For 2,70000/- include (Rs. 20000/- Registration + Rs. 25000/- Total Program Fee)
 - The Total PhD fee for **Science subjects** will be Rs. For 330000/- include (Rs. 20000/- Registration + Rs. 25000/- Total Program Fee)
 - The Total PhD fee for **technical & management subjects** will be Rs. For 405000/- include (Rs. 20000/- Registration + Rs. 25000/- Total Program Fee)
 - The Total PhD fee for **medical subjects** will be Rs. For 4,65000/- include (Rs. 20000/- Registration + Rs. 25000/- Total Program Fee)

ROLES AND RESPONSIBILITIES FOR THE BOTH PARTIES ARE LISTED BELOW:

Role of the University

- KM University will issue offer of admission to eligible candidates in the prescribed format.
- Fees once paid by student are not refundable under any circumstances.

- The student will be under the discipline of the university and will be governed by the rules and regulation of the university.
- The University shall verify the qualifying documents of the students at the time of admission as per the eligibility criteria of university.

ROLE OF A TO Z EDUCATION SOCIETY

- KM University and A TO Z EDUCATION would collaborate to ensure delivery of the 'collaboration programs' as specified by the university and conduct examination as specified by the CoE of the university. Certification for these programs will be conferred by the University to students on successful completion of the course for such programs.
- A TO Z EDUCATION SOCIETY will initiate and recommend for admission of students, identify and recommend subject/ faculty as per eligibility and rules and regulation of the university. The process of enrolment will be that as specified by university or as applicable.
- A TO Z EDUCATION SOCIETY will ensure that students obey and follow the rules and regulations of the University.

TERMINATION:

- This agreement for One Year Only. This MOU can be terminated by the University by giving One Months' Notice and A TO Z EDUCATION SOCIETY by giving One months' notice for the violation of any of the terms and conditions of this MOU.
- However if the MOU is terminated for whatsoever reason the responsibility of each party shall continue to exist till the completion of the collaboration program to which the students have been admitted before the date of such notice subject to the satisfaction of the university.

TERMS & CONDITION OF ABOVE AGREEMENT WILL BE AS FOLLOWS:

- At the time of Course Work, Registration Fee & One year Fee is to be Deposited.
- Account reconciliation will be done monthly and payment will be done on monthly basis.
- Any dispute will come under the Mathura Judiciary.
