And


**RISHIKUL SANSKRIT MAHAVIDHYALAYA**, having UDYAM: UDYAM- (PAN NUMBER: AAKAT8545J) Through Mr. Amit (Aadhar- 790198435876) as Authorized representative having its registered office at Rama Garden, Beside Shanti Vatika Main Gali, Sector 37C, Gurugram- 122001 (INDIA) (here in after referred to as "RISHIKUL SANSKRIT MAHAVIDHYALAYA).

(The University and RISHIKUL SANSKRIT MAHAVIDHYALAYA shall hereinafter individually be referred to as a "party" and collectively as the "parties")

WHEREAS

- I. The K.M. University is a UGC approved university established under Uttar Pradesh State Act No 09 of 2023.
- II. **RISHIKUL SANSKRIT MAHAVIDHYALAYA** is a professional education service provider.
- III. That both parties are desirous of executing an agreement in mutual interest for the benefits of students of the K.M. University in respect of the subject matter hereinafter contained.
- IV. Under the agreement **RISHIKUL SANSKRIT MAHAVIDHYALAYA** would provide its services for counseling of students.
- V. **RISHIKUL SANSKRIT MAHAVIDHYALAYA** has the entire necessary infrastructure including admission counselors.
- VI. **RISHIKUL SANSKRIT MAHAVIDHYALAYA** will be the admission counselor, providing Part-time and Full-time students for Regular Ph.D. and other programs,
- VII. **RISHIKUL SANSKRIT MAHAVIDHYALAYA** counsel & direct students to join University for Ph.D. programs and the total fee will be deposited in university account only and K.M. University will transfer admission fees **RISHIKUL SANSKRIT MAHAVIDHYALAYA** (Fee details and sharing pattern is given as Annexure -I)
- VIII. Account reconciliation will be done monthly and payment will be done on monthly basis.
- IX. **K.M. University** agree that the security check of Rs. 5 lakh. Given by **RISHIKUL SANSKRIT MAHAVIDHYALAYA** will be cleared after fee collection of Rs. 5 Lakh. If the target is not meet by **RISHIKUL SANSKRIT MAHAVIDHYALAYA** then the deposited check will be submitted to the bank. *Cheque NO 000416, ICICI Bank Dated 03.01.2025*
- X. **K.M. University** agrees that they will issue fee receipt of the amount paid by the student.
- XI. **K.M. University** agrees that annexure attached, fee sharing all types of charges/Fees are included such as Registration Fee, Coursework Fee, Examination Fee, Synopsis/ Thesis Submission Fee.

- XIII. **K.M. University** agrees that they will upload the research scholar's thesis on Shodhganga portal after viva conduction. Only when the thesis meet the standard of UGC.

**NOW THEREFORE, IN VIEW OF THE ABOVE AND IN CONSIDERATION OF MUTUAL CONVEANTS CONTAINED HEREIN, THE PARTIES HEREBY AGREE AS FOLLOWS:**

### **1. OBJECTIVE AND SCOPE OF THE AGREEMENT**

The objective of this agreement is to provide the quality education imparted value addition to K.M. University all courses students.

**ROLE AND RESPONSIBILITIES FOR THE BOTH PARTIES ARE LISTED BELOW.**

#### **2.1 RISHIKUL SANSKRIT MAHAVIDHYALAYA**

1) **KM UNIVERSITY** and **RISHIKUL SANSKRIT MAHAVIDHYALAYA** would collaborate to ensure delivery of the as specified by the university and conduct examination as specified by the board of examination of the university Certification for these programs will be conferred by the University to students on successful completion of the course for such programs. **RISHIKUL SANSKRIT MAHAVIDHYALAYA** will provide Guest faculty & faculty co-ordination services and will have liaison with the university. If needed In addition, **RISHIKUL SANSKRIT MAHAVIDHYALAYA** may provide writing and publication services etc, for required students. and organize internship, academic or any other activity to help students to complete the course successfully. In the University Campus if required for the students, will the permission from the University.

2) **RISHIKUL SANSKRIT MAHAVIDHYALAYA**. It will be the responsibility of **RISHIKUL SANSKRIT MAHAVIDHYALAYA** to ensure all approval are taken form university where ever required or where ever there is a reference or mention of university in any communication.

3) **RISHIKUL SANSKRIT MAHAVIDHYALAYA** will provide all documents pertaining to students along with their Aadhar and Residence proff of India. NOC for the part time scholar.

4) **RISHIKUL SANSKRIT MAHAVIDHYALAYA** will ensure that students obey and follow the rules and regulation of the University.

5) Ph.D. entrance Examination of all the enrolled / eligible students will be held through online mode as per the schedule given by the Controller of Examination.


#### **2.2 Role of the University**


1) **K.M. University** will issue offer of admission to eligible candidates in the prescribed format.

2) Fees once pain by student are not refundable under any circumstances.

3) The students will be under the discipline of the university and will be governed by the rules and regulation of the university.

5) The University will verify the qualifying documents of the students at the time of admission as per the eligibility criteria of university.

### 3. TERMINATION:

1. This MOU can be terminated by the **University** by giving One Month notice for the violation of any of the terms and condition of this MOU.
2. However if the MOU is terminated for whatsoever reason the responsibility of each party shall continue to exist till the completion of the collaboration program to which the students have been admitted before date of such notice subject to the satisfaction of the university.
3. The university will make arrangement for completion of the course of the admitted students.
4. Judiciary- Mathura Courts.

### 4. RELATIONSHIP:

Both parties shall always remain as independent entities offering their **services** to other organization. This agreement does not constitute joint venture of agency of exclusive **relationship** between parties.


### 5. MISCELLANEOUS

1. No addition or change in the terms of this agreement shall be **effective or binding** on either of the parties unless reduced to writing and executed by the **authorized representative** of each of the party.
2. This agreement and any annexure will be not executed in two or more **counterparts**.
3. In the event any change in any law, or the passage of any **law, rule** or regulation effects, or in either party's reasonable determination, may affect either **party's performances** or obligations under this agreement of parties shall work together in good faith to **amend this** agreement so as to minimize or eliminate the impact of such change in law on party's **performance or obligation** under this agreement.


### 6. CONFIDENTIALITY

1. All confidentially clauses will apply to this agreement.
2. Each party(the "receiving party") undertakes to keep and maintain **any and all** information received under this agreement from the other party (the "disclosing party") **In the strictest confidence** ("confidential information") and not to disclose (directly or indirectly) **such information** to any third party or make copies of the confidential information without the prior **written consent** of the disclosing party. The receiving party shall use the confidential information solely **for the purpose** of implementing the transaction contemplated herein and not for any other purpose all **such information** shall remain the sole and exclusive property of the receiving party shall return or **destroy such information** to the reasonable satisfaction of the disclosing party however, each party is free to share such information with relevant government authorities, if demanded by such authorities.

All disputes arising out of or in connection with this arrangement shall be subject to the exclusive jurisdiction of the court situated in Mathura.


